# I. 7:00 PM REGULAR MEETING

### B. Presentations

1. Unsung Hero Award – George Lowenstein

# III. MINUTES APPROVAL: May 3, 2016

Mr. Snyder made a MOTION; seconded by Ms. Manion the Doylestown Township Board of Supervisors May 3, 2015 Regular meeting minutes be approved with the following corrections as noted by Mr. Colello:

## IV. CORRESPONDENCES

1. New Britain Township Comprehensive Plan – Draft Update

Ms. Mason referenced New Britain Township Zoning Officer; Devon Ambron's May 5, 2015 memorandum requesting Board comments of revisions made to the 2005 New Britain Township Comprehensive Plan Draft by May 27, 2016. Typically the Board will refer all comments to the Doylestown Township Planning Commission, where a copy has been presented. All Board comments can be incorporated with the Commission's in time of the May 27th deadline. Mr. Garton added; the Board is not required to comment.

For consistency, Mr. Snyder commented the charts listed in the comprehensive plan should reference Doylestown Township, instead of only Doylestown.

## Sound Barrier Evaluation - PennDOT

Ms. Mason reported on the receipt of Kenneth M. McClain's May 9, 2015 letter. Upon the Pennsylvania Department of Transportation sound barrier evaluation along the Carriage Hill Community, the criterion to install a sound barrier along Route 611 and Broad Street interchange has not been met. Ms. Mason added; in addition to the PennDOT rejecting the request, the township does not have funds available to complete the project.

Mr. Snyder questioned was a ramp added after the development was constructed. Mr. Garton responded; the development gave up some land for improvements. Mr. Garton suggested the township staff investigate and provide a commentary noting the discrepancy to PennDOT and State Representatives.

## E. Supervisors

Mr. Touhill reported the Park and Recreation Department has scheduled thirteen events during the Thompson Performing Arts Series, which ends August 14, 2016. The last performance will be a Back to School DJ Dance Party. Additionally, other programs are being developed through the Environmental Advisory Committee (EAC).

The EAC Summit is scheduled for June 16, 2016 with speakers Jeanne Ortiz and David Benner. Weeding continues at the Native Garden, where the next is scheduled for May 28, 2016 from 9:00am to 11:00am. Volunteers are needed. Additionally, there is an effort to the make the Bird Blind more ADA compliant with wheelchair accessibility by updating the ramp.

Mr. Touhill concluded by commenting many of the EAC members are active in different areas within the township. As an example; Jeannine Mitchell will be conducting a bird walk with second graders from Kutz Elementary School. Other members will use their own backyards as part of the Garden tours. Upon a question from Mr. Snyder, Mr. Touhill indicated the Summit will run from 7:00 to 9:00pm.

Mr. Colello referenced a Department of Environmental Protection (DEP) note included in the Board's packet regarding radon requirement. The letter suggests the township place a radon control method as part of the building codes. Ms. Mason responded; the Codes Department is aware of the letter and will have them address the matter. Mr. Colello then noted the radon requirement does not include building which are not new or a townhouse. Ms. Mason offered to double check the issue with Township Code Officer; Salisbury Sinclair.

Ms. Manion reported; the Bike and Hike Committee's Lower State Road trail project is moving along and also has additional, interesting projects in the works. She encouraged anyone interested to attend the Bike and Hike meetings to learn more.

Mrs. Lyons reported; the Bucks County Association of Township Officials have begun discussions on medical marijuana dispensing zoning. She suggested having the Planning Commission begin discussions as well to develop a zoning ordinance.

## B. NEW BRITAIN TOWNSHIP

1. Neshaminy Greenway Trail

## **Regular Meeting**

Ms. Mason reported New Britain Township was awarded a \$1,225,000 million Transportation Alternative Program (TAP) Grant to construct a portion of the Neshaminy Greenway Trail. DVRPC Project Manager; Joseph Banks suggested Doylestown Township, along with Chalfont Borough enter a Memorandum of Understanding to outline their responsibility of the project. The Borough of Chalfont and New Britain Township have already approved the memorandum and seeking approval of the Township with execution.

Ms. Manion made a MOTION; seconded by Mr. Touhill the Doylestown Township Board of Supervisors to execute and enter into a Memorandum of Understanding along with New Britain Township and Chalfont Borough on behalf of the Neshaminy Greenway Trail project.

MOTION was ADOPTED 5 to 0.

# C. LOWER STATE ROAD TRAIL

Ms. Mason explained; the Pennsylvania Department of Transportation ECMS is a electronic management system for grants and projects. In March, 2016 the Board approved a resolution to create a construction inspection portion of the Transportation Alternative Program (TAP) Grant. As a result, Ms. Mason along with Mr. John and Bike and Hike Committee member; Tom Kelso reviewed documents received from several firms, which PennDOT placed on their systems. Pennoni, Baker, Carroll Engineering, TPD and KSE all submitted proposals with fees set by PennDOT. All fees will be paid 100% through the TAP Grant. Pennoni Associates were selected as the engineer for the project.

Mr. Snyder questioned what will be the duties of Pennoni and Associates. Ms. Mason explained; once the trail project is bid and the contractors are on site, Pennoni inspections will ensure the construction of the trail is completed in accordance with the plans.
