

# **NEW RESIDENT REQUIREMENTS**

Doylestown Township does NOT currently require a Use & Occupancy permit/inspection for residential resales. This means that our Code Enforcement Department will not inspect your property or charge permit fees if you purchase a new home in Doylestown Township. However, since we do not require these types of inspections, it can become difficult for us to know when ownership changes. This is why it is important that our new residents file a **Deed Registration** and **Move-In Registration** with the Township's Code Enforcement Office.


## **DEED REGISTRATION**



Ordinance 218 requires that a copy of the deed registration be supplied to the Township when a residential or commercial property is sold. A completed **Deed Registration Form** can be returned to the Township along with the **\$10 fee**. If you submit the Deed and Registration Form with the \$10 fee by mail, enclose a self-addressed envelope if you wish a receipt. Your title company may do this for you at closing, but please feel free to contact the Township Administration Offices to confirm.

## **MOVE-IN-REGISTRATION**

Ordinance 258 requires that all those moving into the Township register using the **Move-in Registration Form**. Landlords are required to register the names and ages of their tenants and provide updates when tenants change. There is no charge to file the Move-in-Permit.



# Septage Management Program

## **Doylestown Township passed Ordinance No. 299 in 2001**

This ordinance requires all residents who currently have on-lot disposal systems (septic systems) to have them inspected by a Doylestown Township approved pumper/ hauler/ installer every **three years**. And, if you also have a private well for water to have it tested for coliform (E-Coli) every **three years**.


### **Why You Need Your Septic System Inspected**

**Protect your property value:** An unkempt septic system can lower your property's value and could potentially cost you in legal liabilities.

**Protect our eco-system:** Contaminated wastewater poses a threat to our local environment. Malfunctioning septic systems can disperse bacteria and toxins to our natural waterways, which in turn can spread into our towns wildlife, endangering native plants and species.

**Protect you and your neighbor's health:** Wastewater can contain disease causing bacteria and toxic chemicals. If maintained properly, a septic system will filter and remove most of these dangerous substances. Otherwise, it can leak causing groundwater contamination, spreading disease to yourself and your neighbors in various ways.

Doylestown Township takes pride in the wide range of activities and amenities offered through its Parks and Recreation Department, serving residents and visitors from Doylestown and the surrounding community.

Central Park, located at 425 Wells Road, spans 140 acres and features scenic nature trails, education and game groves, picnic areas, and the iconic Kids Castle playground.

In 2025, several major amenities were completed, including the Community Recreation Center (CRC), Outdoor Sport Courts (basketball, bocce, pickleball, and tennis), and permanent, accessible restrooms conveniently located near the Amphitheater and Kids Castle.

Central Park also offers two outdoor pavilions available for rent—perfect for summer parties and family gatherings—and is home to the C&N Amphitheater, which hosts the Thompson Performing Arts Series.

Beyond Central Park, Doylestown Township maintains several additional parks:

- Turk Park I – baseball fields and football field
- Turk Park II – baseball fields, multi-purpose fields, fitness trail, playground, and volleyball court
- Turk Park III – dog park and multi-purpose fields
- Bridge Point Park – open green space
- Castle Valley Park – nature trail
- Sauerman Park – kickball field, woodland trail, and picnic area

In addition to these park facilities, the Parks and Recreation Department offers a wide variety of year-round programs for residents and non-residents of all ages—including programs for our canine companions.
