 - Bird Town Bird Walks
 - Sept. 14 Diane Smith from Bucks Audubon led the walk, which was lightly attended. Thank you to Erich and Jane for attending! Some highlights include 2 ravens soaring and the interaction of a young Coopers Hawk with a squirrel. 25 species identified:

 - October 12 starting at 8:30 AM— Next Bird Walk at Neamand Trail behind Mohs Surgery Center. Trish Harrington from Chalfont Boro's Bird Town will support the walk which will be led by Karin Isett. Info went out on the Township's FB page and eNewsletter. Can anyone else attend?
 - YMCA/Girl Scout Native Plant Demo Garden Planning
 - Sept. 26: Met with Anthony from YMCA to review the site;
 - Sept 21: met with Mare at Gino's Nursery with several of the Girl Scouts to discuss the importance of native plants, purchase the plants and load them into my truck.
 - Oct. 4: Chad ordered plant plugs from North Creek Nurseries THANK YOU!
 - Oct. 21: Chad picking up plugs
 - Oct. 26: Planting will take place at YMCA
 - EAC has approved \$500 from the Bird Town Funds from Penn Community Bank donation and the girl scout troop has committed to \$500. YMCA is providing soil and mulch, watering and preparing the site.
 - Costs so far:
 - Gino's Nursery: \$357
 - North Creek Nursery: \$576.07
- Native Plant Garden report
 - 5 attendees at the September work day
 - 2 more work days this season (Oct & Nov)
 - Alice Marcy now leading the Master Gardeners
- Ready for 100
 - Draft report on potential savings generated by Wilson Engineering and shared with the Township staff.
 - Benchmarked the building and it uses 86% more energy than similar type/use buildings
 - Recommended a full recommissioning of the building
 - LEED certification would have required full commissioning of the building, and that may not have been done for this building.
 - PA Solar Center
 - Non-Profit that works with municipalities on solar feasibility and install plan
 - Need to find a cost at around \$0.06/kw/hr to be cost effective since that is how we are billed by PECO

- PA Solar Center Fee \$725 for their scoping work
 - J. Baldassarre proposed that EAC spend \$725 for a feasibility study and EAC agreed to initiate the project with PA Solar Center
