Due to the high number of performer inquiries, we are asking all interested performers to submit a Performer Application.

All applications received will be considered, and if selected, a Performer Agreement and W-9 must be signed.

Sound equipment, lights and sound technicians are NOT included in performance contracts and must be provided by the artist/group.

All applicants will receive a response once bookings are complete. Applications NOT selected will be retained in the event of future opportunity.

Applications, support materials and available video/audio will be reviewed. Applications will be evaluated according to the following criteria:

- Performance quality and Appropriateness (family friendly)
- Quality of support materials (for evaluation)
- Ability to provide a 2-hour presentation. At a minimum 90 minutes is required, *excluding breaks*.
- Self-provided production, including sound, including sound, instruments, supplemental lighting, and other props as needed.
- Willingness to reschedule in event of inclement weather.
- Reasonable booking fees. Subject
