- Light timing on 611 (loop statistics)
 - Grant requests with PA DOT out for adaptive lighting on 611.
 - No update – still pending
- Parkway Updates – changes in traffic patterns and any accident issues
 - Lower State left arrows not cycling correctly – not been noted by Chief Logan . Ryan mentioned similar concerns.
 - No updates
- Review of Wells Road, and possible options, as discussed in Oct.
 - Wells Road – continue observations until April 2013 for speed issues
 - Volumes have decreased since the Parkway has opened
 - Discussion of turn at Radcliffe – Dave suggested a sight distance survey, along with signage as an initial option.
 - Chief Logan did the sight distance survey, and recommendations included signage and possible center line changes.
