## **ACTION ITEMS**

#### REORGANIZATION OF OFFICERS, AUGUST 2021 thru DECEMBER 2021

Acting Chairman, Mr. Joseph Van Houten, announced that the present slate of DTMA Officers is as follows:

At this time, Mr. Van Houten turned the meeting over to the Authority Solicitor, Mr. Rich Magee. Mr. Magee explained that due to the recent resignation of Mr. Richard Bach as Chairman of the Doylestown Township Municipal Authority, an officer vacancy on the DTMA Board needs to be filled with the option of reorganizing the entire Board of Directors.

Mr. Green made a motion to elect Mr. Joseph C. Van Houten as the Chairman of the Doylestown Township Municipal Authority. Mr. Stone seconded the motion and the motion was unanimously approved by the Authority.

Mr. Van Houten made a motion to elect Mr. Kevin Green as Vice-Chairman of the Doylestown Township Municipal Authority. Mr. Stairiker seconded the motion and the motion was unanimously approved by the Authority.

Mr. Van Houten made a motion to elect Mr. Daniel Stairiker as Secretary of the Doylestown Township Municipal Authority. Mr. Stone seconded the motion and the motion was unanimously approved by the Authority.

Mr. Van Houten made a motion to elect Mr. Rod Stone as Treasurer of the Doylestown Township Municipal Authority. Mr. Stairiker seconded the motion and the motion was unanimously approved by the Authority.

Mr. Van Houten announced that Mr. Bob Schaffer was approved at the July Doylestown Township Board of Supervisors Meeting for appointment to the Doylestown Township Municipal Authority.

Subsequently Mr. Van Houten made a motion to elect Mr. Bob Shaffer, newly appointed to the Doylestown Township Municipal Authority, as Assistant Secretary/Treasurer of the Doylestown Township Municipal Authority. Mr. Stairiker seconded the motion and the motion was unanimously approved by the Authority.

Upon a motion by Mr. Green, seconded by Mr. Stairiker and unanimously approved by the Authority. The minutes of the July 15, 2021 DTMA meeting was approved as submitted.

## **AUTHORITY ENGINEER'S REPORT**

#### Contract # 2020-2 CENTRAL SYSTEM WATER MAIN EXTENSIONS

Mr. Ciottoni referenced his letter to the Authority dated July 30, 2021 recommending payment of Payment Application #7 to PACT One, LLC, and reported that all installation work on this project had been completed by the contractor in June with the exception of the remaining 1,500 feet of the water main to be completed on Lower State Road and the Anvil Lane water main. Construction is planned to resume in September.

Mr. Green made a motion to approve the PACT One, LLC, P.O. Box 74, Ringoes, NJ 08551, Payment Application #7 in the amount of \$32,566.00 for work completed on Contract 2020-2 Central System Water Main Extensions. Mr. Stone seconded the motion, and the motion was unanimously approved by the Authority.

#### Contract # 2021-1 BUTLER AVENUE WATER MAIN EXTENSION

Mr. Ciottoni referenced his letter to the Authority dated August 10, 2021 and provided a construction update on this project recommending payment of Payment Application #1 to DOLI Construction Corporation. He explained that the project would be 45% complete by the end of July.

Mr. Green made a motion to approve the DOLI Construction Corporation, 120 Independence Lane, Chalfont, PA 18914, Payment Application #1 in the amount of \$338,602.50 for work completed on Contract 2021-1 Butler Avenue Water Main Extension. Mr. Stone seconded the motion, and the motion was unanimously approved by the Authority.

## **DOYLESTOWN WALK**

Mr. Hass reported that Toll Brothers will start their own on-site water construction in August.

#### **DOYLESTOWN AIRPORT**

Mr. Hass reported the Doylestown Airport contacted DTMA on the possibility of receiving public water. A preliminary meeting will be held to evaluate existing options. The Doylestown Airport is in Buckingham Township and the Cross Keys service area.

Mr. Stairiker made a motion to approve the August 2021 Bills List for the General Fund Account in the amount of \$39,488.90; Developers Escrow Fund in the amount of \$1,060.50; Capital Improvement Fund in the amount of \$393,722.73; Prepaid Invoices in the amount of \$23,775.25; Prepaid ACH Credit Invoices in the amount of \$10,136.30; and Transfers to the Township in the amount of \$92,504.62. Mr. Green seconded the motion which was then unanimously approved by the Authority.

Mr. Stairiker made a motion approving acceptance of the August 19, 2021 Treasurer's Report as presented. Mr. Green seconded the motion, and the motion was unanimously approved by the Authority.
